B. MS in Cyber Security New Program Proposal. Revisions for the Master of Science in Cyber Security New Program Proposal have been submitted. The revised proposal is in the process of being reviewed by Graduate Study prior to being submitted to the Graduate Council. The first reading of the proposal was April 1, 2015. Brad Roth and Bob Noiva volunteered to be reviewers for the 2nd reading at the October 21, 2015, meeting. A representative from the department will be invited to the next Council meeting to discuss the proposal with the Council.

<u>Program Review.</u> Much discussion on policy, process, and how to move strategically forward with program reviews. The need for developing a process and analysis that is helpful and not threating. Is the current schedule and process for reviews adequate or does it need to be revised? A graduate level program review has not been done since 2012. Dr. Petrescu asked the council members to reflect on what direction program reviews need to go and on the current process.

Council agreed to review the PhD in Medical Physics Self-Study and to use it to as a starting point for discussion about what should be included in program review. The council members will review the Medical Physics self-study and discuss at the November 4th Graduate Council Meeting.
