Authors at OU Redux: A Celebration of the Journal

In 2006, we inaugurated our annual **Authors at Oakland University** event devoted to the theme of **A Celebration of the Book**. However, in many fields of knowledge, the journal article is the lifeblood of scholarship. We at Kresge Library recognized the many authors of journal articles at Oakland University on March 22, 2007, by devoting our second **Authors at OU** event to **A Celebration of the Journal**.

The Senate Library Committee reviewed more than 80 articles submitted for consideration, and two entries were selected to represent all of the faculty being honored. The authors of these two articles were invited to discuss their published research with some 80 attendees, and engage in often spirited discussion with members of the audience.

In his article "Public Interest and Private Rights in Eminent Domain: Moving Beyond *Kelo v. New London*," from Business Law Review, Donald Mayer, professor of management and marketing at the School of Business Administration, discussed the current, unsettled state of litigation over eminent domain especially in the aftermath of the recent Kelo decision by the U. S. Supreme Court. He related the issue to the Poletown case in Michigan and the difficulties of balancing private rights and the public good.



Cheryl Riley-Doucet, assistant professor in the School of Nursing, discussed her study on "Beliefs About the Controllability of Pain: Congruence Between Older Adults with Cancer and Their Family Caregivers," from the Journal of Family Nursing. Her research was conducted with patients at local hospitals and the family members who care for them. Frequently, older adults underreport pain because they believe it cannot be treated; sometimes their family members share this belief. The best treatment outcomes occur when both the patient and the family caregiver understand that pain can be effectively treated.



For both speakers, there were questions as well as commentary from the audience, clearly indicating that the authors had addressed timely topics of importance. In the reception before and after the presentations, the many other worthy articles submitted for consideration were perused and a good time was had by all.

OU Alumnus Speaks on Chinese Textiles


On January 31, 2007, we at Kresge Library were proud to host a presentation by OU alumnus Paul Haig (CAS '73) and Marla Shelton. Haig and his assistant Ms. Shelton shared the fruits of his long pursuit and extensive collections of exquisite works in Chinese textiles. Their presentation was based partially on the extraordinarily beautiful book they have recently co-authored, "Threads of Gold: Chinese Textiles, Ming to Ch'ing" (Atglen, PA: Schiffer Pub., 2006).

Some of the items discussed and on display include tapestries, clothing, royal vestments, and various other items displaying astounding skill and artistry.

Haig also shared some of the ins and outs of being a collector, discussing how he evaluates the quality and determines the historical authenticity of the pieces he encounters. This rare opportunity to view samples from his extensive collection was enjoyed by some 80 attendees.

Those present marveled at the artistry on display in numerous pieces of the weaver's craft and appreciated more fully the level of skill and mastery necessary to achieve such outstanding works. A reception and book-signing followed the presentation and discussion. The event was sponsored by Kresge Library, the College of Arts and Sciences, OU Alumni Association, and The Honors College.
