# RESEARCH – "Integration of thought" to address challenging business problems

## Focused research

National Water and Power. Mr. Mike Radice, CEO and Mr. James Charles, SVP are continuing dialog with Dr. Balaji Rajagopalan and Dr. Tanniru on identifying unique service opportunities from customer billing data and marketing these services (an integration of data mining and services marketing).

Comerica: Mr. Jim Cavallier and his team are interacting with Dr. Balaji Rajagopalan and Dr. Karen Markel in the governance and sourcing strategies as well as change management as they plan transformation of a segment of their IT service function.

*GM*: Dr. Mukesh Bhargava (Marketing) and his counterpart Dr. Gary McDonald (Mathematics), working with other business and math faculty, have proposed to develop, validate and refine manufacturing metrics that can be used as a part of management decision support systems for the GM and truck assembly plants globally.

*EB Solutions*: Dr. Vijay Sugumaran is coordinating with Ms. Diane Zuckerman and Mr. David Stark in developing IT architecture for data/device integration during diagnostic support in a health care context. User interface design and economic value assessment will be explored by other faculty members.

Blue Cross Blue Shield: Dr. Miron Stano and the Health Care Management Research Group are in the second phase of discussions to define specific data analysis challenges and develop specific project proposals to move the research partnership forward.

Rochester Legacy Project: The SBA partnership with Rochester community exploring the economic impact of the Rochester Legacy project is on-going under the direction of Dr. Jonathan Silberman and Dr. Nivedita Mukherji.

# **Consortium based research**

Following the round table discussion with the business community on October 15th, an "integrated" business research council (IBRC) was formed to further support collaborative research between council members and research groups. # **Students in Free Enterprise (SIFE)**

The School of Business Administration's SIFE team will compete at the Cleveland Regional Competition to be held on March 19th. Champions in each league from the regional competitions will advance to the competition at the SIFE National Exposition that will be held in Chicago from May13 -15, 2008, and the winner from the Nationals will represent the U.S. at the SIFE World Cup Competition in Singapore later this year. Thanks to Mr. Wayne Blizman for spearheading this effort.

In addition to the competition, SIFE students do community outreach and engage in entrepreneurship projects. In the community outreach area, SIFE students are delivering the weekly Bridge to Life program to students at Pontiac Central and Pontiac Northern High Schools. This program helps prepare students for life after high school. Currently SIFE is launching Project Apolo, an entrepreneurial effort in conjunction with Walgreens. This year, SIFE will be marketing posters at many Walgreens drug stores in the metro Detroit area. This year's SIFE students are also investigating the possibility of launching an entrepreneurial project at the Oakland Center. It is hoped that this can begin this summer.

# **ACHIEVE** program

SBA faculty approved an innovative ACHIEVE program that will provide every business student, starting from their freshman year, an opportunity to practice many business and career development skills. This program will be starting in 2008.

# **Theme Scholar Program**

An in-depth project based program that integrates select course work with an integrated theme was introduced by the SBA last year. This year, a pilot program in "Social and Public Policy" theme will be developed to allow students to integrate their class room learning with issues that impact social and public policy.
