Jay Meehan is an Associate Professor of Sociology and Director of the Concentration in Criminal Justice. His primary research interest and publications are about the practices of police in the United States.

Michael Ponder recently retired from the Department of Sociology and Anthropology where he was a Special Instructor.

Carl F. Barnes, Jr. has been Professor of Art History and Archaeology at OU since 1971. He teaches a wide variety of subjects, from Gothic Cathedrals to James Abbott McNeill Whistler, and offered the only course in erotic art ever taught at OU. Barnes retired January 1, 2001 and is devoting more time to fishing.

Susan Wood is a professor in the department of Art and Art History at Oakland University. His work experience includes senior positions in worksite health and wellness, clinical exercise science settings, and applied health and fitness research. He has been on the exercise science and health sciences faculties of universities in South Africa, Canada, New Zealand and the USA. A Fellow of the American College of Sports Medicine, his scholarly interests are in occupational work physiology; prevention of acute and chronic illness and

injury; and, the development and implementation of task-specific physical readiness evaluations for people engaged in physically demanding occupations. Author of *Dickinson: Strategies of Limitation* and editor of *An Emily Dickinson Encyclopedia*, she has written numerous articles on New England writers from Anne Bradstreet through Robert Frost.

Shea Howell is professor of communication. She came to Oakland in 1979 while working on her Ph.D. at Wayne State University. She specializes in public argument and social movements. Her most recent work is in exploring the relationship between globalization and local place-based communities of resistance. She is interim chairperson of the department of Rhetoric, Communication & Journalism.

Barbara Mabee, Associate Professor of German and Chair of the Department of Modern Languages and Literatures, has been a member of the faculty since 1988. Having originally come as an exchange

student from Germany herself, she established an exchange program between Oakland University and the University of Oldenburg, northern Germany, and more recently with Foreign Affairs College in Beijing, China. Her research interests focus on German women writers, literature of the German Democratic Republic, post-unification literature, German poetry, and Holocaust literature. Her publications include *Die Poetik von Sarah Kirsch: Erinnerungsarbeit und Geschichtsbewußtsein*, three co-authored editions of the second-year German textbook *Kaleidoskop*, and articles on twentieth-century German women writers, the fantastic, the double, fairy tale motifs, infanticide, and images of woman.

Virinder Moudgil, Interim Vice President for Academic Affairs and Provost, and Professor of Biological sciences, has authored more than 200 publications, edited five books and is the Series Editor of Hormones in Health and Disease, which has also published five volumes. At Oakland since 1976, Professor Moudgil has taught Endocrinology, Biochemistry and Biology of Aging. His research has centered on investigating the molecular mechanisms of steroid hormone action with current emphasis on hormonal regulation of tumor suppressor proteins in breast cancer cells. The founder and director of Oakland's Far Field Retreat for Writers, in fall 2002 she will begin teaching in the MFA program at West Virginia University.
