REPORT FROM THE CHAIR

• FALL 2017 ENROLLMENT

OIRA (September 7, 2017)

- On the first full day of class, enrollment is down 4.4% compared to last year
- Undergraduate enrollment is down 4.8%, with returning undergraduates down 4.1%
- Graduate enrollment is down 2% from last year.
- Graduate enrollment is higher in relation to targets, while undergraduate is lower than last year at this time.
- New Master's students are up 1.4%.
- New Doctor's students are down 18% (by 28 student).
- Returning graduate student enrollment is up 1.6%.

• Program Review. Pilot – completed

- Strengths of new model:
 - Short
 - Oriented towards sustainability, change (growth)
 - Students voice is being heard (survey)
 - All faculty are part of the review
 - School/college dean involvement in the process
 - Outcome: Action steps
- Schedule of AY 17-18 program review Pending Provost Decision
- Overdue Program review situation:
 - o 31 out of 69 (total) programs were reviewed 10 years ago
 - 11 programs were reviewed in 2014
 - o 31 were scheduled for program review in 2015 (not completed)
 - 11 were scheduled for program review in 2016 (not completed)
 - o 10 scheduled for review in 2017 (3 were included in pilot)
 - Overall: 49 programs are overdue program review
- Overdue Program assessment situation
 - o 16 grad program assessments are overdue (some since 2011)
 - o 12 grad programs have assessment due October 2017

Graduate Student Exit Survey

- 20% response rate
- Key findings:
 - Overall great experience
 - o research support, career services support, collaboration across disciplines, opportunities for research outside of thesis/dissertation, support for conference attendance, opportunities for grant writing are needed
 - E-space: survey report
