Minutes of the Meeting of the Oakland University Board of Trustees February 24, 1973

The meeting was called to order at 2:25 p.m. on February 24, 1973 in the Oakland Center by President Donald D. O'Dowd.

XIII. Gift from Stolaruk Asphalt Paving Inc. of a road grader to be used on Oakland University grounds, no value has been established.

Approval of Candidates Receiving B.A., B.S., M.A., M.A.T. and M.S. Degrees as of December 22, 1972

President O'Dowd requested Board approval of the candidates for the degrees of B. A., B. S., M. A., M. A. T. and M. S. The list of candidates is on file in the Office of the Secretary.

It was moved by Mr. Schwartz, seconded by Mr. Saltzman, that the degree be awarded to these candidates as of December 22, 1972. Motion carried.

Amendment to Ordinances Regarding Dumping and Littering

President O'Dowd recommended approval of an amendment to the Univers Ordinances defining littering and dumping. After a brief discussion in which Mr. Smith raised some legal questions regarding the proposed ordinance, President O'Dowd suggested holding this recommendation until further clarification in the wording could be obtained. Mr. Carr recommended that the ordinance amendment be tabled until the next meeting.

Approval of Amendment to Constitution of Oakland University Senate Relating to Membership Specifications for the University Tenure and Appointment Poli Committee

President O'Dowd recommended approval of an amendment to the Senate Constitution provisions concerning the membership of the University Tenure : Appointment Policy Committee. The following revision of Article VII, Sectio iv. of the Constitution has been passed by the University Senate, approved by referendum and has the endorsement of Mr. Obear and President O'Dowd:

The Committee shall consist of the Deans of the organized faculties and the Dean of Graduate Study, <u>ex officio</u> and voting, one tenured faculty member elected by each organized faculty who shall also be a member of the Committee on Appointments and Promotions of his organized faculty, and that number of at-large tenured faculty members needed to maintain elected faculty representation at two-thirds of the voting committee membership. The at-large representatives shall be elected by the members of the organized faculties and not more than four of these representatives may be elected from a single organized faculty. The Provost of the University shall have the right to sit <u>ex officio</u> but shall not have the power to vote. Mr. Obear requested that the present appointment term be in effect for the revised specifications on membership, namely, from January 1973 through January 30, 1976.

It was moved by Mr. Carr, seconded by Mr. Schwartz, that the constitution be amended. Motion carried.

Approval of Master of Science in Management Degree Program

President O'Dowd requested approval of the proposed Master of Science in Management degree program presented by the School of Economics and recommended an effective date of September 1973. With approval by the Board of Trustees the University would be in a position to inform the State Board of Education of the program and proposed starting date.

Mr. Smith thanked Dean Johnson and Dean Seeber for presenting a very comprehensive outline of the new program at the Executive Session of the Board.

It was moved by Mr. Katke, seconded by Mr. Lewis, that the program be approved. Motion carried.

At the conclusion of these formal agenda items, President O'Dowd requested any further comments or statements from the members of the Board. Mr. Lewis asked for the status of the University Congress election. Mr. Coffman stated that the election had been invalidated by the Validation Committee. The Congress has named a new elections committee and the election will be run on March 21 and 22.

Mr. Lewis asked if this was in compliance with the review committee and Mr. Coffman concurred.

Mr. Smith stated that he understood that the constitution of the Congress will be rewritten and he hoped that in the future the constitution would be written so clearly that there will be no further invalidating of an election. Mr. Coffman indicated that the Congress intends to rewrite the constitution after the election and present it to the Board for approval.

President O'Dowd pointed out that the present document represented the will of the students and is not in the form that the Student Affairs Office recommended for adoption. President O'Dowd expressed the hope that the students will want to change the constitution into a more workable document. Mr. Smith suggested that since the Board needs to approve the constitution perhaps the students should have the assistance of the University. February 24, 1973

Mr. Lewis inquired about the status of the University's position on salary disclosure. President O'Dowd stated that the State Attorney General has not ruled on this issue and that the Board had determined at a previous meeting to withhold any action until an opinion was rendered.

Mr. Katke moved for adjournment. Seconded by Mr. Saltzman, the meeti was adjourned at 2:55 p.m.
