There are four primary activities of the Teaching and Learning Committee: 1) make recommendations of one full-time faculty and one part-time faculty members for the Teaching Excellence Awards, 2) recommend allocations of the educational development grant funds, 3) publish the committee newsletter, "Insights and Ideas for Teaching and Learning," and 4) sponsor faculty luncheons to promote outstanding teaching and learning practices.

Fall Semester

During the fall semester the committee refined the criteria for the teaching excellence award and designed a web-based nomination form. This form was made available to students, faculty, staff and alumni in early November with an early December deadline. Announcements soliciting nominations were sent by email from the Office of Academic Affairs to all faculty members. Our request for email announcements to students was not as successful. After weeks of delays an announcement was included in a general broadcast message from Communications and Marketing. However, an informal poll taken by committee members found no students that had read this announcement. The primary means for reaching students were a banner in the Oakland Center, an announcement on their electronic message board and by faculty telling their classes about the nomination process. Despite our inability to communicate directly with all students we did receive many nominations by students as well as several by faculty and staff. Listed in Table 1 are the fourteen full-time faculty and twelve part-time faculty nominated for the 2005 Teaching Excellence Awards.

The committee sponsored a fall luncheon featuring Professor Tomas Giberson from the School of Education and Human Services speaking on "Differences in Generational Learning Styles." The luncheon was well attended with Professor Giberson keeping all actively involved in exercises to show how the learning styles faculty experienced as students differ greatly from those of our current students.

Winter Semester

During the winter term the committee published the first of two newsletters (the second will be published in May) featuring articles by the 2004 Teaching Excellence Award winners. In the winter issue Professor Djamel Bouchaffra from the School of Engineering and Computer Sciences discussed his teaching philosophy and methods in an article, "Teaching, an Art and a Mutual Challenge." In the May issue Gerald Compton, Lecturer and Chemistry Laboratory Manager, provides insights into his teaching style in "Looking for Mona Lisa's Smile: Twenty-five Years of Teaching General Chemistry." The May newsletter also shows the comments made by Vice Provost Susan Awbrey at the winter luncheon honoring all nominees for the Teaching Excellence Award. This luncheon was the first time all nominees were so recognized. Each nominee's dean or designee provided a brief summary of their contributions to teaching excellence at Oakland. We strongly urge future committees to continue this recognition for we have far more outstanding teachers than can ever be recognized with two awards per year.

In January and February the committee reviewed the materials collected to support the nominations for the Teaching Excellence Awards and made the recommendations listed below. During this term the committee solicited proposals for educational development grants. Thirteen proposals were received from 15 faculty members as shown in Table 2. Committee recommendations made after thorough reviews of all proposals are shown in Table 2.

Recommendations for future committees

It is recommended that the 2005-2006 Teaching and Learning Committee in the fall term address the following issues with respect to the Educational Development Grants:

- 1. Should part-timer's be able to submit proposals where the budget is allocated toward salary? The guidelines state that the award should not go towards salary. However, the committee felt that part-timers made less salary than full-timers and in fact, the grants were not required for their position, and hence should be rewarded for their effort.
- 2. Are multiple proposals by one person acceptable or is this simply a way to get around the dollar limit on grants?
- 3. If a person submits multiple proposals that are acceptable, and there are a limited number of applicants, should that person get multiple awards?
- 4. We need to add deadlines to the guidelines that specify when a faculty should hand in their progress report or their final report showing the outcomes from their proposal.
- 5.We need to start an electronic list that lists the people that did not hand in final reports and progress reports, where they would not get additional funding until the outcomes of the previous report was submitted to the committee. This electronic list would be passed on to the new chair after the previous chairs' term has ended for continuity and enforcement.
- 6. Should we delineate in the purpose of the grant that grants should not include curriculum changes, which are departmental issues, or should it be left up to the committee to decide?
