

Minutes of the Meeting of the Oakland University Board of Trustees September 24, 1975

The meeting was called to order by Mr. O'Dowd at 8:25 p.m. in Lounge II of the Oakland Center.

Mr. O'Dowd asked Mr. Obear to comment upon the personnel actions resented to the Board for approval.

Mr. Obear called attention to the seventeen new faculty appointments and Ar. August J. Durelli's appointment to the John F. Dodge Professorship of Enineering. He also noted with regret the resignation of James H. Bullock who acepted a position at the State University in New York at Binghamton as Assistant Tice President for Minority Student Affairs.

It was moved by Mr. Katke and seconded by Mr. Saltzman that the personel actions be approved.

Mr. Lewis asked Mr. Coffman to explain the rationale for including the esponsibilities for the Public Safety Department under position #6, Director, Physical Plant Services.

Mr. O'Dowd stated that a great deal of time had been spent trying to onceptualize public safety in a very broad sense to include, for example, life afety.

September 24, 1975

Mr. Coffman explained that it was a matter of broadening public safety concerns to deal with not only police functions but fire safety, life safety, and the OSHA compliance features. He announced that Mr. George A. Catton, who is currently the head of the State Fire Marshall Division, and who is a person with broad safety and police experience will provide the leadership in this area as the Director of Physical Plant Services.

The motion was voted upon and the personnel actions were approved.

Reappointment of Laszlo J. Hetenyi, Dean of the School of Education

Mr. O'Dowd recommended the approval of the reappointment of Laszlo J. Hetenyi as Dean of the School of Education for a five-year term from August 15, 1975 to August 14, 1980. Dean Hetenyi has had a long and distinguished career; he assumed responsibility for the development of the teacher education program in 1960 and has completed fifteen years as the administrative leader of a vital segment of the University's instructional program.

Mr. Lewis moved to approve Mr. Hetenyi's reappointment as Dean of the School of Education for a five-year term. Seconded by Mr. Smith, the motion carried.

Acceptance of Gifts and Grants to the University

Mr. O'Dowd recommended acceptance of the gifts and grants.

It was moved by Mr. Lewis and seconded by Mrs. Adams that the gifts and grants be accepted with gratitude.

Mr. Smith stated that it should be made clear that the grants are given for specific projects and are not to be used at the discretion of the University. He also expressed concern with reference to the Pontiac School grant to be used under the lirection of Mr. Bullock since he has resigned. Mr. Obear reported that Ms. Martha Bass has been appointed the Director to replace Mr. Bullock with the apporoval of the Pontiac School system.

Mr. Swanson reported that the gift of office furniture from Mrs. James C. Zeder the value of which was undetermined at the time the Board agenda was prebared has been appraised at \$3,735.

The motion to accept the gifts and grants, which have been submitted by he Office of Business Affairs in two lists, was voted upon and carried.

Approval of Union Contracts

Mr. O'Dowd requested that Mr. De Carlo read the following resolution regarding the AAUP contract:

WHEREAS, the Board of Trustees has reviewed the terms and provisions of the proposed collective bargaining agreement between Oakland University and the A. A. U. P. for the period July 1, 1975 through June 30, 1976, which has been negotiated and recommended for adoption by the bargaining representatives of the respective parties, and

WHEREAS, the Board of Trustees approves of the terms and provisions of the proposed agreement,

THEREFORE, be it resolved that the President is authorized and directed to execute on behalf of Oakland University the aforesaid collective bargaining agreement subject to the ratification and execution thereof by the A. A. U. P. and the approval of the document as to form by legal counsel for the University.

Mr. Smith moved to accept the resolution. Seconded by Mr. Katke, the notion carried.

Mr. O'Dowd requested that Mr. De Carlo read the following resolution egarding the Clerical/Technical UAW Local 1925 contract:

WHEREAS, the Board of Trustees has reviewed the terms and provisions of the proposed collective bargaining agreement between Oakland University and the UAW Clerical/Technical Local 1925 for the period July 1, 1975 to June 30, 1976 which has been negotiated and recommended for adoption by the bargaining representatives of the respective parties and,

WHEREAS, the Board of Trustees approves of the terms and provisions of the proposed agreement,

THEREFORE, be it resolved, that the President is authorized and directed to execute on behalf of Oakland University the aforesaid collective bargaining agreement subject only to approval of the document as to form by legal counsel for the University.

Mr. Lewis moved that the resolution be adopted. The motion was econded by Mrs. Adams, and carried.

Adoption of University Budget for Fiscal Year 1975-76

Mr. O'Dowd requested that Mr. Swanson review the proposed budget for 1975-76.

Mr. Swanson stated that the budget for the 1975-76 fiscal year had bee delayed well beyond the beginning of the fiscal year due, in part, to the date the appropriation was approved and the absence of collective bargaining agreements At this point in time, he stated, there is still some uncertainty as to the final appropriation level due to the threat of additional cutbacks by the Executive Offi and the Legislature. Based upon the appropriation currently allotted to this Un versity, the following balanced budget was submitted for the Board's approval:

Mr. Swanson indicated a tuition increase is recommended with reluctance for the winter semester in order to balance the University budget. Tuition would amount to about \$22.00 per credit hour.

Mr. O'Dowd summarized that the total budget recommendation is \$19,506,415 and includes a tuition increase of \$1.50 per credit hour for undergraduate courses and \$2.00 per credit hour for graduate courses.

Mr. Lewis stated that after having had an opportunity to review all of the facts and figures relating to the University's fiscal condition, he reluctantly moved to approve the budget and the increase in tuition.

Mr. Katke offered the second to the motion.

Mr. O'Dowd recognized a request from Mr. John Lawton, President of the University Congress, to make a statement. Mr. Lawton read the following:

Members of the Board,

As official representatives of the Oakland University student body, we, the Executive Staff of the Oakland University Congress, strongly urge that you postpone, for a period of one month, consideration of the question concerning a raise in undergraduate, graduate and out-of-state tuition. We feel that this one month period will allow us sufficient time to mount a concerted campaign directed toward influencing members of the Michigan State Legislature in an effort to increase the State funding directed toward Oakland University.

It is apparent that, due to continued pressure from Lansing, the University administration has exhausted all singular efforts to resolve Oakland University's economic shortcomings. We feel that since the proposed increase is warranted due to faculty and staff wage and benefit adjustments, that as a unified group we could provide possible alternative methods for the funding of Oakland University to the State Legislature.

This request has been necessitated by strong verbal dissatisfaction from many members of the student body directed at we, the members of the Congress Executive Staff.

Tuition increases resulting from contract settlements affect the entire University community. It would be greatly appreciated if we were given the opportunity to mobilize that community to aid in the betterment of the overall university experience. Mr. Chris McBride, a student, stated that the student body was extremely concerned about the cost of higher education and that many of his associates were "poverty-stricken" due to the economic climate. He requested that the Board delay their action on tuition for one month since the students could not afford to pay additional fees.

Mr. O'Dowd stated that the tuition increase was required and that it would not have been recommended if the need was not critical. If the tuition increase is not approved then the University will be faced with further cuts in personnel.

Mr. Lewis stated that in light of the petition of the University Congress, he wished to amend his motion. He moved for the adoption of the budget recommended by Mr. Swanson which would include revenues to be received from a tuition increase; however, the motion would not include the adoption of the tuition schedule but postpone any action in this matter until the October Board meeting.

Mr. Saltzman stated that he would support the motion, but the issue gave him great concern. He did not wish to be a party to what could be construed as an artificial response to the students since the funds are required and it was unlikely that additional resources could be received from the Legislature.

Mr. Jim Bier, representative of the student government, stated that he was not personally confident that they would be able to "find the money, but the students did not wish to stand idly by since there have been reports that tuition costs would continually increase over the next decade."

Mr. O'Dowd observed that the University has made every effort to obtain funding. The institution was successful in obtaining a good appropriation in a very poor economic year. It was his opinion that this was only the beginning of a national trend for higher tuition. If funding was not obtained through tuition increases there would be a reduction in total institutional quality.

Mr. Katke stated that he did not wish to appear to be disrespectful of the interests of the students but he observed that it should be clear that the students were representing themselves and not the Board of Trustees nor the University in their efforts to obtain additional funding from the Legislature. He stated that the University's representatives have reviewed all of the issues with the Legislature and have been treated very fairly and in some instances, it could be stated, better than the other institutions. In view of the fine relationships that currently exist with the Legislature he did not wish to prejudice the institution's position. Mr. O'Dowd shared this concern by stating that there is a possibility that an interpretation could be placed upon the action of the students to the effect that the University was ''putting them up to the issue.''

Mr. McBride again asked for the floor and stated that the students' efforts should not be considered as a slight to the University or its staff. They recognized the problems of the University and were merely requesting an opportunity to share their concerns with State officials.

Mr. Obear stated that the timing of this action was critical since the Board would not meet again until October 22. The Registrar's Office is scheduled to distribute material to the student body three days later. Action on a tuition increase cannot be delayed beyond the Board meeting date of October 22.

Mr. Katke agreed to second the amended motion by Mr. Lewis and the motion carried.

Mr. Lawton thanked the Board for their action and stated that the student body would do its best to protect the interests of the institution and student body.

Authorization to Establish a Piano Practice Fee

Mr. O'Dowd recommended approval of the establishment of a piano practice fee, which would cover a limited number of pianos and would be applied toward the cost of monthly tuning.

Mr. Lewis moved to adopt the following resolution:

RESOLVED, that the Board of Trustees authorizes the administration to assess a \$10 per semester piano practice fee for those students wishing to use specially designated and maintained pianos in the Department of Music. In addition, authorization is granted to collect a \$5 refundable key deposit for access to the rooms containing the specially tuned instruments.

The motion was seconded by Mr. Saltzman and carried.

Approval of Candidates Recommended to Receive Bachelor's and Master's Degrees as of June 21, 1975

Mr. O'Dowd asked for formal approval of the graduating list of June 21, 1975, a copy of which is on file in the office of the Secretary to the Board of Trustees.

Mrs. Adams moved to approve the list. Seconded by Mr. Lewis, the motion carried.

Contract for the School of Nursing

Mr. O'Dowd asked Mr. De Carlo to discuss the contracts entered into by the School of Nursing with various health agencies.

Mr. De Carlo reported that some of the health agencies cooperating with the School of Nursing for the training of students have approved the contract draft prepared by the University and others have made amendments.

He further stated that it appeared advisable to submit all contracts to the Board since there is potential malpractice liability involved. He recommended that the Board approve the contracts with Avondale Convalescent Home, Rochester; Lakeside Community Health Center, Pontiac; Macomb-Oakland Regional Center, Fraser; Martin Place Hospital-East, Madison Heights; and Pontiac General Hospital, Pontiac, in the form drafted by the University and contracts with William Beaumont Hospital, Royal Oak, and Memorial Hospital of Warren as amended and approved by counsel. (Contract forms are on file in the Office of the Secretary.) The contracts have also been reviewed and approved by the University's insurance carrier.

Mr. Howlett commented that the Board is undertaking serious exposure to professional liability when sending nursing students into hospitals to care for patients. The University must use care when signing contracts to prevent assuming unnecessary risks. Whatever liabilities are imposed must be covered by insurance. He assured the Board that these points were adequately covered in the contracts recommended for approval.

Mr. De Carlo stated that Dean Felton had indicated to him that all the student nurses will also have individual malpractice insurance.

Mr. Lewis moved that Oakland University's School of Nursing enter into contracts with the following agencies: Avondale Convalescent Home, Lakeside Community Health Center, Macomb-Oakland Regional Center, Martin Place Hospital-East, Pontiac General Hospital, William Beaumont Hospital, and Memorial Hospital of Warren in the form recommended by counsel. Seconded by Mrs. Adams, the motion carried.

Senate Amendments

Mr. O'Dowd read the following resolution:

WHEREAS, the Board of Trustees has under Article VII of its By-Laws recognized the University Senate as an organization to advise the President in regard to academic policies and programs, and continues to endorse and support the activities of the University Senate, and

WHEREAS, the Board of Trustees has not heretofore taken formal action to ratify or approve a Constitution of the University Senate as contemplated by Article VII of its By-Laws, and

WHEREAS, the Board of Trustees acknowledges that the Senate has in fact been operating under a Constitution ratified on February 28, 1967, and amended in March, 1969, and that further amendments have recently been proposed for approval by the Board of Trustees, and

WHEREAS, the Board of Trustees believes that it would be appropriate rather than granting its approval of the proposed amend ments to request that a new Constitution be drafted in a format which is consistent with the governance documents approved for other advisory bodies within the University.

IT IS THEREFORE RESOLVED as follows:

1. The Board of Trustees reaffirms its support of the University Senate as an organization to advise the President in regard to academic policies and programs.

2. The Board of Trustees recommends to the University Administration and to the Senate that a new Constitution of the University Senate should be drafted which will embody the essential terms of the prior Senate Constitution and the recently proposed amendments thereto in a format which will be consistent with the pattern of governance reflected in Constitutions which have been approved by the Board for other advisory organizations. Any employment contract affecting the Constitution will relate to and only affect those employees covered by that contract. 3. Until such time as a time as a Senate Constitution is submitted to and approved by the Board of Trustees, the Board directs the President to give due consideration to the advisory actions of the Senate which are duly adopted under its current constitution as amended, but the recognition of such actions shall not be deemed to constitute approval of a constitution as contemplated by Article VII of the By-Laws.

It was moved by Mr. Saltzman and seconded by Mr. Smith that the resolutic as read by Mr. O'Dowd be approved. The motion carried.

Meadow Brook Hall Resolution by Trustee Carr

Mr. Katke read the following resolution in behalf of Mr. Carr:

WHEREAS, the Board of Trustees of Oakland University reviews on a continuting basis the operation of Meadow Brook Hall: and

WHEREAS, the Board of Trustees is familiar with the many accomplishments of President Donald D. O'Dowd, Dean Lowell R. Eklund and the entire managerial staff, including the harmonious resolution of countless problems encountered on a daily basis in the operation of the Hall, the attraction of thousands of persons to the many successful programs conducted in the Hall, the placement of the facility on a favorable financial footing and the careful preservation of the unique cultural legacy thereof--all of which is due to the complete devotion of its stewardship and the deep dedication of its hundreds of volunteers;

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Oakland University affirms its confidence in the management of Meadow Brook Hall and its satisfaction that the considerable responsibilities attendant thereto have been exercised in the best interests of the University, the people of the State of Michigan, and the memory of the donor, Matilda R. Wilson.

Mr. Katke moved the resolution be approved. Seconded by Mr. Lewis, the motion carried.

Mr. Saltzman announced with deep regret that the Board was informed this evening of the resignation of Trustee Otis M. Smith from the Oakland University Board of Trustees to be effective October 1, 1975. He therefore requested the opportunity to read the following resolution:

The Board of Trustees accepts with great reluctance and sadness the resignation from this Board of its former Chairman, Trustee Otis Smith. Trustee Smith has served Oakland with great distinction just as he has served in other posts during his long and brilliant career in public service. We are grateful for his service and counsel and recognize that time pressures have forced him to resign. We hope that he will continue his association with the University insofar as he is able.

I, therefore, move that Otis Smith be designated as Trustee Emeritus with all attendant rights and privileges and urge him to take full advantage of them.

The motion was seconded by Mrs. Adams, Mr. Lewis, and Mr. Katke. The motion carried.

Mr. Smith said he is leaving Oakland with sadness but hopes to come back n many occasions. He stated that it had been a great privilege for him to serve he University.

Mr. O'Dowd commented that Mr. Smith had been with the Board from the irst day the body assembled. The University has grown since that day with his uidance and his help has been greatly appreciated. Mr. O'Dowd wished Mr. mith success in all his academic and community endeavors as well as his usiness commitments.

Mr. Sheldon Appleton asked to be recognized. He stated that with the atification of the AAUP contract his term of office as an observer to the Board f Trustees was over. He expressed much pleasure in attending the Board neetings and recognized that the members extended a great deal of time, interest and energy to the affairs of Oakland University with no compensation. He stated nat it was his wish that students and the general public who have become dislusioned with public officials could have the opportunity to observe the Oakland or in action. He said it was gratifying to see a group of people doing their est to exercise the public trust that has been given to them. He expressed the ope that the Board had a mutual feeling regarding the faculty whom he felt were lso "trying to do their best." Mr. Appleton informed the Board that his replacement would be Mr. Gottfried Brieger. September 24, 1975
