## IX. Discussion Topics

### a. Financial Aid Concerns and Discussion

**McGuinness:** A letter to the editor of the Oakland Post, the complaint was a student and his wife that lives in family housing, they received a certain amount of financial aid, but it was decreased because married housing is not considered as on campus housing.

**Caver:** I have had several student complaints. Paperwork is not being processed from May 2005. They are short staff, but there will only be a turnover of people who currently work in the office. There will only be one additional staff person hired. Cindy of Financial Aid assured me that this was a University not a financial Aid decision on hiring only one person.

**Evans:** It seems that the people who work in the office currently are not well advised on financial aid. There have been complaints on customer service. If there is a shortage at least have those who work there, be informed of financial aid.

**McGuinness:** They are working how more students can get more bang for their buck by offsetting fees and it may either increase or decrease tuition. There is a question of who gets what and how much.

**b. AMU Conference**

**McGuinness:** For the first time in Oakland's history, we will be hosting the Association of Michigan Universities' Conference. We need to know who will attend.

**Allyson Cummings-Stuckman:** Can we know what rooms it will take place
