#### VIII. Discussion Topics

a. Discussion Topic of the Week- Dance and Major Events Policy

**M. Miller:** sat on committee over the Summer, we proposed an extensive amount of things, it was relayed that changes were not added to the policy; they were too complicated or not acceptable. Upset... we need to address the fact of not having a policy.

**Ewing:** I'm having difficulties obtaining the text, how are student organizations planning events without getting it? I see loopholes in what organizations are allowed to do and what organizations are. The university talks about student life but tramples events, did very little to solve problems but protect university from lawsuits. We should ensure that everything will be the same for all orgs. Yield to M. Miller.

**M. Miller:** True with people being exempt from the policy. For example, the 112 concert we didn't have medal detectors when committee said that we would. The student body should be protected at all events, it is unfair. It should be written that all organizations be subject to these policies.

McGuinness: I sent letters to all organizations concerning this topic. What message is being sent to student organizations, James Earl Jones is free and open to everyone; all friends can come. They all come from student and public money (STUDENT ACTIVITIES FEE) We have administration that say that because it's solely from Student Activities Fee, it should only be open to students. Something could happen tomorrow, that is humanity.... It is our world. It's not right.

**Ewing:** Loopholes for some organizations as opposed to others, James Earl Jones vs. Gaming Guild... prime example. "Ghost Policies" aren't being taken seriously because students don't buy them. Shouldn't close ourselves off to the public; we are closing off alumni, and hindering the progress of the University.

**Mersol-Barg:** With Gaming Guild nothing has changed; I have kept in contact with the secretary. The university is trying to increase student involvement. Allowing events to be open to public opens more opportunities for the University. Policies are counterproductive.

**Waquad:** This goes for dance and residence halls policies. Administration doesn't listen to student input. This turns away perspective students.

**Cummings-Stuckman:** We shouldn't be blocking people, but the dangerous things they bring in. Student Organizations Were sent an email to come and talk about it but weren't given inadequate timing.

**Mersol-Barg:** We all agree that policies aren't protecting students; we need to focus on solutions.

**McGuinness:** Jean Ann Miller sent Steering Chair Miller and me a copy of the policy; the issue is the major events policy wasn't solidified. 1 guest per student is allowed previously it was two.

**Allen:** There are a lot of leaders from student organizations in the gallery. Encourage all of you to place suggestions in the OUSC suggestion box concerning this matter. The more students we have backing us, the better the situation.

**Hardenburgh:** Dance Policy not final, formatting must be done.
