**VI. Old Business**

**a. C.R. 06-11 (Affirmative Action Resolution-Kubicek,previously postponed)**

**Kubicek:** motion to amend the resolution to state whereas statement (WHEREAS, Oakland University Student Congress has acknowledged that affirmative action benefits the staff and faculty at Oakland University, therefore benefiting the students and enhancing the educational experience that the university provides; and)

**M. Miller:** Good amendment, and ties into what all sponsors are saying, and why it benefits Oakland University and it's students

**Ewing:** If the MCRI passes in Michigan, does that end all programs or will it cease to be a requirement

**M. Miller:** Affirmative Action is not forced on anyone; we wouldn't be able to participate in particular programs.

**K. Miller:** Like the amendment because it ties it back to the University; keep the personal agendas and political views out of it.

**McGuinness:** It would take away the university's autonomy of how they want to run the university, will eliminate several programs...ex. King-Chavez-Parks Programs, Project Upward Bound Progam; amendment is very accurate in saying that it impacts students and faculty and staff.

**b. C.R. 06-12 (Affirmative Action Resolution-Mersol-Barg, previously postponed)**

**Mersol-Barg:** Shouldn't tell students what to think, but give them the tools to make their own decisions; educate, not dictate; I think it is inappropriate to take a stance.

**M. Miller:** We just passed the resolution that would contradict this resolution, and we should take a stance. We are student government, it's our job to educate; we have the opportunity to examine facts and do what's best of the students. The past resolution doesn't dictate. We are not dictating; we are doing what's best for the students.

**Point of Personal Privilege: Danielle Fallis**

**Waquad:** If the past resolution wasn't passed, I still wouldn't support this resolution. If we don't take a stance on anything it would cripple the organization.

**McGuinness:** There have been ballot proposals every year, and since 2000 OUSC has taken a stance on a particular ballot proposal.

**Ewing:** I'm in the middle of a lot of research, which is why I didn't support the previous resolution. There are many nuances that we still need figure out; I think that educating the student body is great, but it would seem funny to some people that Congress said vote no...but here's some information.

**Mersol-Barg:** Disagree with precedent set in the past, my resolution takes a stance, and says that this issue is important, taking a stance but giving information is contradictory. It's a matter of ensuring that OUSC serves the students in the matter of our capacity.

**Porter:** Every Bill takes a stance in some shape or form, Mark made a good point about knowing all the information, but this had been up for approval for a while now, we could "Goggle" and much information would come up. It is pointless to have this conversation, I call to question.

**Motion: FAILS**

**M. Miller:** We are not an educational body, that is not the role of this body or government. Congress has already taken a stance on Affirmative Action, and there are a lot of people that have sponsored the resolution. Maybe we should amend the resolution.

**K. Miller:** I don't think there is anything wrong with Congress taking a stance on this proposal. I think it's in the best interest of the students to encourage the students to vote "no"; just giving information does not draw students' attention.

**Zatkoff: Yield to Dean Maurer**

**Dean Maurer:** I wish that as my student representatives you would stop telling me what to do. Stop taking a stance on issues that you can't control. Take a stance on Financial Aid; that's something you can control.

**Mersol-Barg:** There is very strong language in my resolution. I don't think it's appropriate that OUSC takes such a stance.

**Cummings-Stuckman:** I was one of the people also supporting Proposal 2; educating didn't help, taking a stance is what got students out; there is a positive way to do this and this is how we do it by making a decision.

**Roatarius:** Reiterate the language of the previous resolution; doesn't say that we urge the student body to do anything technically.

**Kubicek:** Met with Mr. Mersol-Barg; if questions needed to be asked they should've been asked, so I call to question.

**Motion: Passes**

**Resolution: FAILS (*Mersol-Barg with rights*)**

**Mersol-Barg:** Taking a stance was a backlash, and made students lose trust in the Oakland University Student Congress, it is unfortunate.

**(Ewing: I am not opposed but I don't have all the answers) <let's the records show>**

## **VII. Discussion Topics**

### **a. Discussion Topic of the Week-Affirmative Action Issue**

**Redmond:** A lot of people were for affirmative action, and some people said that they weren't directly affected by it; and I got one response

against it, he said submission into jobs shouldn't be based on whether you're black or a woman.

**McGuinness:** Spoke at the Residence House Council meeting, and encouraged students to attend the meeting. Met with the Dean of Students and he was the past director of the Center for Multicultural Initiatives, past Office of Equity, and understands the needs for a diverse campus.

**K. Miller:** We don't solely depend on affirmative Action, and I'm sorry that you don't feel represented, but it's not Congress' job to represent all students but we should represent what's best for the students. I think it is an ignorant statement to say that the students will vote a certain way because student congress took a stance; it is insulting to the students.

**Mersol-Barg:** I got mixed reviews; some said yes, some said no, others said that OUSC shouldn't take a stance. I'd be interested to see the response to the stance that OUSC has taken.

**M. Miller:** A lot of people have no idea of what Affirmative Action is. There was a young lady that was against Affirmative Action until I explained to her what it was.

**K. Miller:** Not student Congress' job to represent the opinions of all students; didn't mean previous statement "not to represent all students"

**McGuinness:** African-American Students are underrepresented, and it is our responsibility that all students are represented. Each student should have the power to be heard.

**K. Miller:** I thought that while talking Affirmative Action, I think that the CMI's Mission Statement only has African-American, Latino-American, Native Americans; what about Asian Americans, women and the LGBTQ community?

**Porter:** CMI represents all minorities, although it isn't written. Everyone needs to do their research on Affirmative Action.

**K. Miller:** CMI doesn't help with other programs with minority students, but they have a hand in the African-American Celebration.

**J. Miller:** I received mixed reactions on Affirmative Action; that is due in part of students not knowing; I don't know everything myself; I encourage everyone to do the same (educate themselves)
