  - a. C.B. 07-19 (Proposed Constitutional Amendment, second reading)
    - i. Joshua Miller- Length of confirmation help to see the devotion and responsibility of the individual up for nomination. Undergraduate in turn could stay in office if continuing to graduate school at Oakland. It will again not be transforming the Disciplinary Committee to the Judicial Branch.

The purpose of congress is to serve the students, and this branch would not benefit students. The Judicial Board will cause a barrier between executive board and Legislators.

To maintain such membership or position a student need not be enrolled during Spring or Summer semesters.
