B. Niem Alatassi

C. Approval of Validations Committee, *Madison Kubinski*

1. Students: Cassie Hock, Nate Catey, John McQuillen, Itzel Marroquin
 - a) Ms. Kubinski introduced the students of the validations committee, commenting that Ms. Hock and Mr. Catey had both been Legislators, Ms. Marroquin had been on her previous committee and Mr. McQuillen wants to get more involved.
2. Administrative Professional: Amy Ring-Cebelak

D. C. C.B. 17-12 Lend a Hand, Warm a Heart, *Luna Nasry*

1. This bill is something Ms. Nasry is passionate about, the Syrian conflict has been ongoing, refugees have been dispersed everywhere. This initiative will help raise awareness, and get coats for these people. The time of year makes this

initiative advantageous because people are getting rid of their winter coats. The coats will be going to the Syrian American Refugee Network. Legislator Nasry said that students will get swag in return, which will incorporate welcoming people from all ethnicities. Ms. Nasry stated that the coats must be less than the value of the coats.

a) Ms. Kubinski said that this initiative is reminiscent of one that Kat Cotton had done a year ago, Grizz Gives to Kids, she suggested handing out similar sweatshirts as last year with a catchy slogan. The initiative was successful last year, and she thinks that this one will be equally so.

b) Legislator Walton asked when this would start and end?

(1) Legislator Nasry said that this would start as soon as this bill is passed and would go until the first week of the April at the latest.

c) Legislator Jagtap asked if Legislator Nasry had considered expanding it at all.

(1) Legislator Nasry said that she, but she's wary that students may abuse it. Coats at this time are needed because refugees are dying of hypothermia, maybe next year it can be extended and expanded.

d) President Thomas said that this is a wonderful idea. The current budget is our budget for a while, you could continue this past April.

1. Legislator Sanders said that this resolution shows support to student who need it, and an extension be needed instituted, he hopes you support it.

F. C.A. 17- 01 Constitutional Amendment Bill, Ryan Fox

1. In the absence of Legislator T Fox, Legislator R Fox presented the bill. Legislator R Fox described the amendment process, first it goes to Congress, then the Student Body, then the BOT. These amendments do a few things, but mostly it increases the inclusion on campus. The graduate council would focus on their own issues, any student can be on that committee, but it will specific issues that affect graduate students. Student athletes would have a new spot on Congress so that athlete issues are heard. Finally, the Judiciary committee should not have legislators on it because they could be biased towards those who are on trial

2. President Thomas stated that these changes would be more specific in the bylaws. The graduate population would do better to represent these grad students Athletics would have their own representative because it would allow for more inclusiveness and representation. Also, there would be a better definition ex-officio, so it would read "by virtue of office." Finally, it would get rid of the

five legislator requirement, as most of our committees have more than that number in both legislators and non-Congress members. There will be continued discussion in the interim, which will most likely result in a slightly different bill.

a) Ms. Kubinski voiced her support of this bill, however also stated that she was concerned because these changes are coming so close to the elections. Furthermore, she stated that the last time the Constitution was amended it the Student Body voted it down because students said that they didn't understand the changes and there wasn't enough time to learn about them.

b) Ms. Mishack said asked if we aren't making graduates a rep and just a council, wouldn't there be a risk it isn't always filled. She also stated it would be better to be a graduate student, and thinks it should be in the requirements.

(1) President Thomas said that he thinks the leader of the committee doesn't have to be a graduate student, but this is where the bylaws come in. The goal would be to fill the position at all times. The logic of this is that there is no official graduate student congress, and that's why it would be a committee. However, if graduate student wanted to create their own body they could.

c) Ms. Mishack stated that staying consistent and having a graduate student position would be more helpful.

d) Ms. Shippy asked if anyone had talked to any grad students about this, to see if it was an actual issue.

(1) President Thomas said that it originated from a student concern. Tyler Parsons sent a really long email about this issue after he talked to his fellow grad students about it.
