- Program seems to have only one year full time option. Could students decelerate program to complete over two years?
- Typo in Item #5. HRD 6951 Lean Leadership Internship I should be HRD 6951 Lean Leadership Internship II.
- o All courses appear to be hybrids. Could there be a 100% distance option?
- Could an individual with no business or management coursework at the undergraduate level enroll in the program?
- Will undergraduate transcripts be reviewed for course content? What criteria or coursework will they look for?
- o Is GPA evaluation necessary? Will a GPA less than 3.0 be considered under an additional set of admissions criteria? What would those criteria be?
- Operating expenses were not included beyond the first year.
- No administrative support is included.

- o Financial support for faculty seems low, especially considering oversight of the internships.
- No inclusion of support for graduate assistants.
- o No mention of support for recruiting and associated costs.
- No letter from the library is included. What additional library resources would be needed and budget? Should a librarian be requested to conduct a needs analysis for the proposal?
- o No documentation of support letters from participating and impacted schools and departments.

Committee recommended having the concerns addressed in a revised version of the proposal prior to considering first reading.
