#### **Outstanding Graduate Student Mentor Award**

Gary Barber raised concerns about the proposal and concurred with Ms. Free's request. The Council supported a two-week postponement of the vote. ## V. NEW BUSINESS

## **Graduate Admission Application deadlines**

A list of the Oakland University graduate application deadlines for fall and winter semesters was distributed. The graduate application deadlines, as presented, are in concert with other institutional deadlines including those from the offices of the Registrar, Student Affairs, and Financial Aid.

Ms. Schott-Baer reported that the number of graduate students requesting financial aid assistance has increased substantially over the past several years. In fact, a growing majority of graduate students entering Oakland University at this time depend on financial aid (loans, scholarships and graduate assistantships). Because of this, applications and supporting materials must be submitted in time to accommodate the admission process and allow students time to apply for financial aid. She confirmed that competitive programs can opt for earlier deadlines; however, program deadlines scheduled <u>later</u> than the university's graduate application deadlines will not be permitted.

Donna Free asked for information about the application deadline for Summer II session. Claire Rammel replied that there is no application deadline for either Summer I session or Summer II session. There is only one deadline for the entire summer semester. All graduate applications and supporting materials must be received by the approved deadline for summer semester.

Robert Noiva asked how graduate admission deadlines align with undergraduate admission deadlines. In reply, Claire Rammel stated that they don't align because they serve different purposes: undergraduate students are admitted to the university; graduate students are admitted directly to programs.
