Minutes of the Meeting of the Oakland University Board of Trustees December 1, 1973

The meeting was called to order by President O'Dowd at 4:30 p.m. in Room 128 of the Oakland Center.

Approval of Minutes of October 24, 1973

On a motion by Mrs. Adams, seconded by Mr. Carr, the minutes of the meeting of October 24, 1973, were approved.

It was moved by Mr. Katke, seconded by Mr. Schwartz, that the personnel actions be approved. Motion carried.

Approval of Faculty Reappointment and Tenure Recommendations

President O'Dowd requested approval of the appointment and tenure recommendations submitted to the Board. The recommendations cover individuals whose contracts normally terminate at the end of this academic year. There are two sets of recommendations: Reappointments and Nonrenewal of contracts

Traditionally, nonaction by the Board to renew a contract terminates employment at the end of the academic year.

Mr. Smith moved for adoption of the recommendations and stated that the Board had reviewed the procedures used in making these recommendations with great care. Mr. Saltzman seconded the motion.

As a point of information, Mr. Saltzman inquired whether a faculty member might be tenured in two departments if two were listed.

Mr. Obear explained that a faculty member may have a joint appointment, but the tenure recommendation comes from the primary department, which is underlined in the report to the Board.

Mr. Katke inquired if the rank of special instructor designated a short-terr position. Mr. Obear stated that this rank is defined in the appointment procedu

and faculty agreement and is not used as a part-time or temporary designation. A faculty member appointed for three two-year terms acquires job security with the fourth appointment.

Mr. Smith inquired as to the difference between the terms "job security" and "tenure." Mr. Obear stated that both provide some of the same provisions, except for sabbatical, and that as long as a departmental position existed, the incumbent special instructor has a right to job security.

Professor Carl Vann asked for recognition and stated that it was his understanding that a faculty member acquired tenure with the University and not with a specific department.

Mr. Obear stated that he did not intend to indicate that faculty members. receive tenure in a department. A recommendation comes from a department, but tenure is acquired with the University.

Professor Robert Williamson asked for the names of those faculty members who were promoted to associate professor with tenure. Mr. Obear explained that there were no promotions to be considered now; the recommendations under consideration were all reappointments, some of which result in tenure.

Mr. Williams then requested that the names be read of those faculty members recommended for reappointment, involving tenure. Mr. Obear read the following names:

Professor James McKay asked if Mr. Obear would read the names of those who are not being reappointed.

Mr. Obear stated that it would be inappropriate for any officer of the University to identify these individuals publicly. President O'Dowd stated that Mr. Obear was following Board policy.

Mr. McKay asked that the record indicate that the Board received a petition from the faculty.

Mr. Smith acknowledged that the Board has received and considered the petition from the faculty.

Professor Harvey Burdick inquired if formal action on nonreappointments had been made at a nonpublic meeting.

President O'Dowd responded that it was not and that the Board acts only on reappointments. No action is required if an individual is not to be reappointed. He stated that the Board had been informed thoroughly that there is a list of people involving nonaction on reappointment.

Mr. Schwartz explained that the Board is fully aware of the existence of a nonreappointment list and the Board realizes that if they do not take action, the consequence is nonreappointment. The reason for the procedure in not making the names a matter of public record is in the interest of these people.

Mr. Burdick objected to the Board not taking action on nonreappointments.

Professor Liboff inquired whether the Board had considered all the procedural matters and the appeals mechanisms.

Mr. Smith stated that he thought it fair to say that the Board had considered these matters in some detail.

Professor Liboff asked if the Board was satisfied with the appeals procedure. Mr. Smith stated that it was his understanding that all of the Board members were satisfied.

President O'Dowd explained that the appeals procedures followed those agreed to by the faculty by contract.

Mr. James Howlett, University Attorney, confirmed that all procedural aspects have been carefully reviewed. He has counseled with the Board and is fully satisfied that the rules have been followed.

Professor Liboff stated that he has received a letter from the Provost that there is no means to appeal the procedure.

Professor Carl Vann asked whether the Board considered "what was done or how it was done." He wondered if the Board had made both considerations.

Mr. Saltzman answered that the Board reviewed "extensively what was done, both procedurally, and to the best of our ability, substantively." The Board felt the procedures were adequate.

Mr. Smith stated that he is confident that the procedures established by the University have been followed religiously as to each person.

Professor George Feeman inquired as to whether the Board reviews the records of the people being recommended for reappointment, or merely checks procedures and relies on someone else's recommendations.

Mr. Smith stated that the Board has been advised that its responsibility is to review procedures.

Mr. Feeman explained that the Board might be agreeing to an inaction for a person whose record might be quite good, but the Board would have no knowledge of whether the record is good or not.

Mr. Smith stated that the review process is very thorough. The Board has sought to examine each particular case to determine whether or not these rules were followed. He stated that the Board is interested primarily in procedures.

December 1, 1973

Professor David Mascitelli asked how the Board makes it recommendation when it receives a set of conflicting recommendations.

Mr. Saltzman stated that the Board received no conflicting recommendations. The recommendations came from the President. The Board has been informed that certain groups in the University did not concur.

Professor McKay asked that the record show that the Board does not receive recommendations from anyone but the President. He said it should be shown that this is the basis upon which the Board is acting.

Mr. Schwartz stated that this would not be a correct statement for the record. He stated that the Board received recommendations from the President and the Provost. They have also fully advised the Board of the recommendations of other groups in the University. He stated that the Board has been advised of the fact that, in some instances, these recommendations are not in agreement.

In response to an inquiry, Mr. Obear stated that all recommendations from the University Tenure and Appointment Policy Committee are reported to the Board by him as chairman of that committee. These recommendations are not separate, but are formulated in the context of the entire list of recommendations. Mr. Obear stated that he has also forwarded his own set of recommendations because he has an appropriate review responsibility to carry out.

Mr. Williamson asked to again discuss the appeal procedures. He stated that several years ago a Board subcommittee reviewed procedures and there are now very complete regulations about department level review. Colleagues may appeal such decisions and ask for reasons for the recommendations. Up until now, there has not been a serious conflict between departmental recommendations and those of the Provost and the President. Now there is no way to find reasons for judgments made by these administrators.

Mr. Schwartz inquired as to whether Mr. Obear had been sought out and had informal meetings with those individuals not recommended for reappointment.

Mr. Obear answered, "yes."

Mr. Schwartz continued and asked Mr. Obear if these individuals then questioned what recommendations he would be making to the Board. He also asked if they had the opportunity to learn the basis of the Provost's recommendations.

Professor Jean Braun stated that the faculty was specifically told that they would not be informed.

Mr. Obear objected to this statement saying that these were two separate issues.

Mr. Obear stated that he made himself available to all of the faculty members who were informed that they were not recommended to the Board for either promotion last June or reappointment this November to discuss informally this action. He stated that he had told them that he could not place reasons in writing, but could discuss the recommendations.

Professor Feeman stated that he was involved in one meeting with a faculty member and only the criteria used was discussed and not the actual reasons for the decision.

Professor Sheldon Appleton asked if the Board was in agreement with the AAUP statement included in the faculty petition.

Mr. Smith stated that he was quite aware of what this question inferred. Because there is a grievance pending, he stated that he would not comment further on this subject.

Mr. Smith stated that obviously there is disagreement on some recommendations. He stated further that the rules state that action must be taken at this time. He indicated that the Board has shown great flexibility to consider new rules, but he was moving now for a vote because action had to be taken on the recommendations. He understood that there had been mutual agreement in the procedures, and if there is a desire for the Board to consider more elaborate and different procedures, he had an open mind to that possibility. He stated that he is willing to discuss change, if change is warranted. However, the Board is called upon to make a decision based upon existing rules. Furthermore, there does not appear to have been any injustice on the application of existing rules to the present cases.

Professor Liboff asked that the record show that the Department of Physics was not permitted to give additional information after the distribution of letters informing individuals of what recommendation would be brought to the Board.

Professor Leo Gerulaitus stated that the people not being reappointed now should be given the benefit of any new procedures developed in the future.

Professor Feeman stated that Mr. Obear sent a letter indicating that if he could supply new information on a faculty member, he might agree to reconsider the case. Mr. Feeman spent several weeks getting information and sent it to the Provost and it was then considered to be inadmissible because of pending legal action. Mr. Feeman then inquired if the Personnel Subcommittee of the Board would agree to meet with department chairmen regarding the consequences of the actions to be taken with respect to maintaining and recruiting faculty. He thought it would be very enlightening if the chairmen could share with the Board some of their viewpoints.

Mr. Smith asked Mr. Howlett about any legal problems involved in complying with this request in view of the pending grievance.

Mr. Howlett recommended that until such time as the grievance procedure is exhausted, the Board should decline and then the constraints of collective bargaining should be considered.

Mr. Smith stated that the Board is very approachable directly and indicated that they wish to know everyone better. He stated that the Board appreciates what the faculty members are doing and what they have done. The Board would wish to consult with the chief administrators; however, they could be contacted after resolution of the grievance.

Approval of Resolution Regarding Interfund Borrowing

President O'Dowd requested approval of a resolution regarding interfund borrowing. At the October 24, 1973, meeting of the Board the Audit Committee was asked to recommend a resolution for adoption by the full Board. Mr. Katke asked Mr. De Carlo, as Secretary to the Board, to read the following resolution:

"Whereas, it had been the long-standing fiscal practice of Michigan State University-Oakland, to pool the cash resources of the several university monetary funds and to account for the use of such cash resources as interfund borrowings and debts; and

"Whereas, Oakland University, since the date of its becoming a separate university, has continued this practice since there was no other financially practical alternative available, and "Whereas, it is deemed to be in the best interest of the university for the present only to continue such practice and to use interfund borrowings, including borrowing from the Retirement and Insurance Fund, as a means of interim financing of fund deficits including the continued funding of the Meadow Brook Theatre deficit and a portion of the construction cost of Hamlin Hall, both incurred prior to the legal separation of Oakland University from Michigan State University, and

"Whereas, the legal counsel to the university has advised that the borrowing of funds and practice of interfund borrowing are within the legal authority of the Board of Trustees to manage and control the financial operation of the university, and

"Whereas, the present Board of Oakland University acknowledges the practice of pooling cash resources and interfund borrowing, as originated under the governance of Michigan State University,

"It is, therefore, resolved that the Trustees of Oakland University will pursue a course of action with the University administration that will be calculated to substantially reduce or eliminate the need for funding any accounts, including certain large accounts, namely Meadow Brook Theatre and possibly Hamlin Hall, so that current and future interfund borrowing can be controlled within fiscal practices more acceptable to the Board of Trustees."

It was moved by Mr. Katke, seconded by Mr. Schwartz, that the resolution be adopted. Motion carried.

Approval to Assess Special Fee for the Course Art History 315

President O'Dowd requested approval to assess a special \$10 fee for students enrolled in the course Art History 315. The request is based upon the costs of special materials which will be provided for the course.

It was moved by Mr. Schwartz, seconded by Mrs. Adams, that the assessment of \$10 be approved. Motion carried.

Approval of Copyright Policy for Oakland University

President O'Dowd requested approval of the following copyright policy for use by Oakland University:

Oakland University Copyright Policy and Procedures

Members of the Oakland University faculty, staff, and student body are free to publish and, where appropriate, to copyright results of their work, except in those cases where materials are produced as a result of ongoing job assignments or under special arrangements for commissioned work, as indicated below. Thus, textbooks produced by Oakland University faculty members have routinely been copyrighted by the author or authors, while works produced in connection with normal assignments in various administrative offices generally have not been copyrighted. Special commissioned assignments have occasionally produced materials which have been copyrighted in the name of the University (e.g., "Science and the College Curriculum," Hoopes, 1962 - produced with support from the University and the National Science Foundation).

The University reserves the right to enter into agreements to commission creative works in those cases where the University (with or without the help of an external agency) and one or more members of the University community have a common interest in combining talents and resources in order to undertake a specific short term effort (e.g., production of instructional films or tapes, text books, musical compositions, specialized computer software). Each such agreement shall be carefully drawn in writing to specify the nature of the assignment, the expected contributions on the part of various individuals and units of the University, estimated costs and a schedule for distribution of income from royaltic rentals, licenses, and so on. Once endorsed by all involved parties and signed by the President of the University, an agreement shall become binding. Since the nature of the work, the total costs, and the distribution of these costs among various units of the University must be taken into account in determining equity in income, no typical pattern can be postulated.

The responsibility for developing and monitoring commissioned agreements for the production of materials to be copyrighted in the name of the University will reside with the Director of Research and Instructional Services for such advice and assistance (e.g., the University Counsel) as may be needed.

It was moved by Mr. Schwartz, seconded by Mr. Katke, that the copyright policy and procedures be adopted. Motion carried.

Authorization to Enter into an Agreement with Denyes and Freeman for Architectural Services for the Public Safety and Services Building

President O'Dowd requested approval for the University to enter into an agreement with the architectural firm of Denyes and Freeman for the Public Safety and Services Building. The agreement is for a fixed fee arrangement, which is in accord with the new contract forms approved by the Joint Capital Outlay Committee of the Legislature.

It was moved by Mr. Smith, seconded by Mr. Carr, that authorization be granted.

Mr. Saltzman asked if, in view of the energy crisis, this building was still critical to our needs and appropriately designed.

Mr. Brown stated that we do not anticipate a change in design of the Public Safety and Services Building. However, a consultant has been retained to review the design. He stated that as soon as the report is received, it will be shared with the Board.

Motion carried.

Approval for Change in Purchasing Policy

President O'Dowd requested approval for the University to change its purchasing policy for purchases requiring a bid procedure from a \$200 limit to a \$500 limit. This recommendation would assist the Purchasing Department because many firms are located in the Detroit area and will not spend time and money to travel to Rochester to bid. This figure is more in line with other universities around the State.

It was moved by Mr. Smith, seconded by both Mr. Carr and Mr. Lewis, that the \$500 limit be approved. Motion carried.

Approval for Extension of Time for PIRGIM Program

President O'Dowd requested Board approval to extend the lenth of time allowed PIRGIM to gain contributions from one-third of the student body. He explained that because of pre-registration this fall, it was felt that PIRGIM did not have adequate advertising time. President O'Dowd therefore recommended that

PIRGIM be allowed to use the winter term and the fall of 1974 to reach the mandatory requirement of one-third student participation to continue to collect funds.

It was moved by Mr. Katke, seconded by Mr. Lewis, that this recommendation be approved. Motion carried.

President O'Dowd stated that this ended the list of items on the agenda and asked for comments from the audience.

Professor George Feeman requested information regarding the copyright policy. He inquired how issues would be resolved if there was a conflict between a faculty member and the University or if a faculty member refused to sign the agreement.

Mr. O'Dowd explained that the Board has approved the establishment of a procedure, whereby a contractual agreement can be effected and more detailed provisions can be developed in the future. He also stated that any legal questions would be handled by counsel.

Mr. Howlett stated that problems would be resolved by Mr. Pino since he will develop procedures implementing the policy.

President O'Dowd added that he has received information on the establishment of a legal aid information service on campus. He asked for reactions from the members of the Board.

Mr. Smith stated that he thought the plan for the program was very well done. He thought the University community had a demand for this pilot project which has been carefully reviewed by the Oakland County Bar Association.

Mr. Carr moved to adjourn. The meeting was adjourned at 5:40 p.m.
