**Annual Report** 

I am pleased to report to you and the University Senate on the activities of the University Research Committee (URC) during the 1993-94 academic year. Attached to this letter you will find a list of committee members as well as our fiscal year 1994 annual report. I would like to comment briefly on each of these items; in addition, I will discuss other committee endeavors.

Committee Membership: To a person, the 1993-94 URC members were cooperative and hard-working. Given the inherent scheduling problems for such a large committee and the large numbers of meetings, absences were minimal. Everyone on the committee took their responsibilities seriously. Because of extensive pre-meeting preparation, meetings were efficient and productive. I am appreciative of the support and counsel of ex officio member, Don McCrimmon. His office was consistently helpful to the committee, and Don personally helped to facilitate our deliberations on some difficult issues. I am especially grateful for the assistance of Pat Beaver of the Office of Grants, Contracts, and Special Projects. Without Pat's editorial expertise and historical perspective, the chairmanship of the URC would be an administrative nightmare. Pat is indeed the rock that steadies the committee.

1994 Fiscal Year Annual Report: As the award summary shows, the URC expended about 90% of its total budget to support faculty fellowships. An additional 8% was used for grants and special projects to facilitate faculty research. The majority of committee time was devoted to careful review of fellowship and grant proposals; for example, we were only able to fund 16 of the 27 fellowship applications we received. The committee also devoted time to the review of applications for supplemental funds from the Alumni Association and the OU Foundation. We awarded alumni-supported grants to six undergraduate and two graduate students. We made decisions on two

conference grants (Meadow Brook and Alumni) and selected two outstanding researchers for OU Foundation recognition. In reviewing and selecting the above awardees, I am pleased to note that the committee found evidence of quality scholarship in every corner of the campus. The committee is impressed with the creativity and drive of our faculty colleagues and our students. It would have been a pleasure to disperse additional funds.

Additional Committee Activities: Besides our mandated disbursement activities, the URC was able to devote time and effort to the following research-related events and issues.

September activities: The URC attended the dedication of the Research Excellence Award Plaque in the Kresge Library. The chair attended an informal AAUP reception for new faculty to apprise them of the intramural research funding opportunities at OU and to encourage them to apply for fellowships. The URC discussed the impact of the proposed Nursing and Health Sciences merger on the research environment at Oakland.

November / December activities: The URC reviewed carefully and extensively the "Alleged Misconduct Policy" for the VPAA. Several substantive changes were suggested. As a result of our suggestions, a joint faculty-administration committee was established to rework the policy.

January activities: The URC and the AAUP Ad Hoc Research Committee met with Vice President Russi for a discussion on research at OU. The groups were especially interested in how the VPAA's views had evolved during his first six months at OU. A discussion summary was printed in the OU News.

March/April activities: The URC reviewed the joint committee draft of the "Misconduct Policy" and made additional suggestions. The URC voiced concerns to President Packard about proposed budget cuts in the new science building and in Hannah Hall renovation funds and their anticipated negative impact on the research efforts of many of our colleagues. The committee also reviewed and revised the many documents (eg guidelines, program announcements, application forms) that are critical to its function.

Spring/Summer activities: At the direction of the committee, the chair is communicating with President Packard about implementation of a previously-proposed faculty seminar series to be supported by her office.

In summary, the URC had a very busy and productive year. I am pleased that we were able to tackle some significant issues in addition to our mandated review activities. If you require any additional information, please don't hesitate to contact me. I will be on sabbatical during the fall term but will be generally available except for the last three weeks of September.
