V. Comments from the Gallery

Mark Ewing: Why if the number of students is increasing on campus is the number of student representatives on Congress decreased? Financial aid is like a foreign country! There is no reason that no one had knowledge of anything when I call financial aid! The University must think outside the box. Every time a student has a problem they shouldn't have to drive to campus to get a question answered. Another problem...I understand that there wasn't quorum during the summer. There should be legislators here to get things done.

VI. Old Business

a. C.B. 06-02 (Bylaws and amendments-SPB Guidelines, second reading)
M. Miller: Pretty basic, I will accept any questions.
McGuinness: SPB is the entertainment arm of OU. We are in the process of approving the bylaws.

Amendments: Approved

a. C.B. 06-03 (Fall/Winter Budget, second reading) Stevens: Reads budget. (Written)

McGuinness: This budget and where we dedicate our money sets the course on what we can do for the year. There are specific reasons why we have the things on the budget as we have described. The PAWS program is ran by K. Miller, M. Miller, and L. McCullough. New items, Newspaper readership program. Last time, the price was too much. We are now getting more bang for our buck. With the experience with the then new TAP Program, we now see that we need \$2000 instead of \$8000. Anti-Hate Campaign....NEW! We are also adapting to the new initiatives that the faculty is taking with new scantrons. Financial Aid seminar, CMI is in need of \$100 for this seminar for the program.

K.Miller: Student, Fred Denault asked for some kind of Student employee appreciation.

Glatfelter: I like to amend to strike the line item for USA Today, and move it into uncategorized. Although it is less expensive, I think that it is a bit much. If we strike USA Today, it would be less costly. I don't think we should spend as much just yet. If it works out we should bring in more papers.

McGuinness: We did have a four week trial period, and it worked well last semester at no cost to the students. We can't have one without the other. They are also contributing a couple of hundred dollars for The Association of Michigan Universities as well that could also free up more money.

Stevens: Is the money for AMU contention on us passing this motion?

McGuinness: No conversations have been made on that.

Glatfelter: Withdraw Motion Withdrawn

Nahas: Propose and amendment of \$100 for the Financial Aid Seminar.

Schroers: I think that scholarship should be increased.

Waquad: Jean Ann has pointed out that OUSC is not an entity for scholarships. We should take that into account.

Nahas' Motion: Approved

Porter: I'm looking at publicity for the Oakland Post is \$2500. That is a large amount. Do we need that much money for publicity with the Post?

McGuinness: A 1/25 ad in the Post is \$40. We may advertise for a meeting, PAWS, multicultural round table, and several other initiatives.

Stevens: To elaborate, OUSC purchased an \$80 ad for an 1/8 of a page ad per week. It is down from last year. With the initiatives the amount is about right.

Kopson: The Student Congress Fall/Winter retreat is \$3000. What is that money going toward, because it seems like a bit much.

K. Miller: I actually asked for a little more. I didn't go to the last year retreat, but I heard it wasn't a positive experience. \$3000 is not that much for 25 people.

McGuinness: That is not just for Fall but also for Winter, so that cut down the per person cost. It contains more than a single retreat.

Porter: Mr. McGuinness, can you explain under environmental awareness, what is the "continuation of Spring/Summer Initiative.

McGuinness: Yield to K. Miller

K. Miller: I don't think I asked for this much. I was thinking about an environmental ice cream social, or something along those lines.

M. Miller: To reinerate on K. Miller, I think that student employee appreciation would be great.

McGuinness: The money for the committees' use to come out of the meeting line item. The committees come up with the ideas, and what decisions to make, what to be voted on.

Waquad: I wanted to touch on the environmental awareness. VP Caver was researching smoking on campus, and her findings weren't as successful as she had hoped. I think it is important that we keep it in the budget.

Kopson: I think that we should set money aside for a student employee appreciation month. Take \$300 from uncatergorized funds.

Waquad: How much of a safety net do we need the uncatergorized funds?

Stevens: That (uncatergorized) is the safety net. We could have \$0 and still have money.

Nahas: How would the student appreciation fund be used?

K. Miller: Since Fred brought the initiative to Madalyn and I, we'll let him plan it. I think he will join the Student Services Committee. It is totally discretionary.

Porter: We don't have enough money to fund every student employee. Why would we have the money to support a few if we could do some.

K. Miller: It's the thought that counts.

Waquad: Employees are in need of appreciation.

Porter: Everyone should feel a part of this. How many people talk pass the banners now, and don't read them.

Jones: I am a student employee, but I would feel more appreciated if my boss did it for me rather than Student Congress.

M. Miller: It sounds contradictory. If you can do a little thing to make someone happy, that's an accomplishment. It's good to make people feel good. \$300 is not that much money.

Kopson: It is the little things. It would obviously be something that would benefit everyone.

McCullogh: We shouldn't take the student employees for granted.

Evans: If all the student employees can't benefit from it, then KNOCK IT.

Hardenburgh: Grand Valley formed a committee formed for student employee appreciation. Employees get a card about the Story of the Star Fish, Then Hot Dog, Raffles and prizes come next, Thursday and Friday, departments are asked to appreciate their employees. This is just a suggestion.

Nahas: I think spreading a little joy is great.

Waquad: It was never an option to support some employees. How can you pick and choose?

Fred Denault (Student): I'm happy with OUSC that they are taking initiative on this particular goal.

Jones: I agree that we should push for the departments. It means more when you are appreciated by someone you have been working for.

Stevens: Students appreciating students is great. We can't expect them to do it.

Allen: One of our problems is we don't expect the department to do certain things when we should. They should appreciate their employees, and if we don't expect it that doesn't say too much about us.

J. Miller: Motion to call to question

Motion: Passes

Glatfelter: I would like to take \$1000 from uncatergorized and put \$500 in Fall and \$500 in Winter Semester Scholarships. The tuition has been raised and our purpose is to help students in any way we can. Every little bit that we can give to students is a big help.

Ujla: When we went to Board of Trustees Meeting, they said that with tuition increase, there is a financial aid increase.

Nahas: I'm uncomfortable with the uncategorized funds decreasing, could we spend some funds in future deliberations rather than spend it now. Wait a little while and see how it goes.

Stevens: The uncatergorized funds are safe. The more we spend the closer we get is the best way to use the money. The \$5000 in our Master Account is what helps us to be safe.

Porter: According to the Constitution, we must have \$5000 in our account.

Stevens: The only way that I see to set aside money for anything is to increase the President's discretionary fund. Any rollover is not serving the students in the following semesters.

Glatfelter: Scholarships are a helpful thing for students. The higher the fund, the more students we are able to reach.

Porter: I don't feel we should spend all the monies in the uncatergorized funds. Things may happen, if we spend it all we will come into problems.

Motion: Fails (11:3)

Budget: Approved 17- yes 1- no 1- abstention

Evans: Would the discretion be left up to the archivist to what is included in the archives.

Evans: would there be a way for members of Congress to have a say so, I think it is important.

Kopson: Is this something that needs a first and second reading?

J. Miller: This is a bylaw so this is our first meeting.
