Council members recommended that a few minor changes be made to Ms. Hege's slide and that she should work with a mentor on her presentation prior to the competition.

OLD BUSINESS

A. Graduate Certificate in Finance - New

Reviewers: Robert Noiva and Kris Thompson

First Reading: Debatable, amendable, but not eligible for final vote at this meeting.

Questions/concerns raised by Graduate Council members:

- All boxes on delivery method have been checked
- The proposal suggests that no new resources are needed as existing space and courses will be used. It would have been helpful to get an idea of how many new students are expected to enroll in courses to complete this program.
- O How would applicants missing identified preparatory work (Financial Accounting and Quantitative Methods) be handled? Will they be required to complete requirements before application or before enrollment? Would those credits be treated by OU as graduate or undergraduate credits? Could they be used to apply to a Masters?
- o Is the program 15 or 18 credits total (15 required credits and 3 elective credits or the elective is only taken when FIN 5330 is waived)?
- O Do students always need to start in the Fall? Are courses offered each semester? Will the courses be offered using different delivery formats at the same time? How would students know to plan their program of study?
- o Should undergraduate required work include Financial Accounting and Quantitative Methods?
- Would exceptions to the 3.0 GPA requirement be made? How would the granting of an exception be handled?
- o Are they indicating that some of the required courses would only be offered on the Macomb campus?

B. MEd in Higher Education Leadership - Modification
