**E. New Items for Consideration/Action**

**Real Estate Lease Agreement – Focus: HOPE**

Dr. James P. Lentini, Senior Vice President for Academic Affairs and Provost, presented the Real Estate Lease Agreement – Focus: HOPE recommendation as set forth in the agendum item.

RESOLVED, that the Board of Trustees authorizes the Senior Vice President for Academic Affairs and Provost to execute a real estate lease agreement with Focus: HOPE; and, be it further

RESOLVED, that the lease agreement be reviewed and approved by the Office of the Vice President of Legal Affairs and General Counsel prior to execution, and be in compliance with the law and University policies and regulations, and conform to legal standards and policies of the Vice President for Legal Affairs and General Counsel.



In response to a question from Trustee Flynn, Interim Dean Gary Moore indicated that the attrition rate in the LPN program is mostly due to students who start the program who've taken the pre-requisite courses and have struggled with those pre-requisite courses.

In response to a question from Chair Schlussel, Assistant Dean of Finance Cheryl McPherson stated that students from Detroit are generated because of OU's name and reputation as well as other students referring them to the OU program. Focus: Hope is also helping to bring students to the program and provides services for the students. There is currently a wait list of approximately 200 students for the program.

Mr. Moore explained to Trustee Robinson that the LPN is a national license which is controlled by the National Council of State Boards of Nursing.

After discussion, Trustee Tull, seconded by Trustee Melissa Stolicker, moved approval of the recommendation, and the motion was unanimously approved by those present.

**Meadow Brook Hall Operating Budget for Calendar Year Ending December 31, 2015.**

Ms. Robin L. Gardner, Director of Administration and Finance, presented the Meadow Brook Hall Operating Budget for Calendar Year Ending December 31, 2015, recommendation as set forth in the agenda item.

RESOLVED, that the Board of Trustees approve the 2015 Budget for Meadow Brook Hall.

Ms. Gardner explained that operating revenue was above budget because of increased facility rental revenue. Gifts and grants is about \$100,000 above budget due to a life insurance policy that was expiring that was cashed out.

After discussion, Trustee Kramer, seconded by Trustee Tull, moved approval of the recommendation, and the motion was unanimously approved by those present.

**Golf and Learning Center Operating Budget for Calendar Year Ending December 31, 2015**

Mr. William M. Rogers, Director of Golf and Learning Center, presented the Golf and Learning Center Operating Budget for Calendar Year Ending December 31, 2015 recommendation as set forth in the agenda item.

RESOLVED, that the Board of Trustees approves the Oakland University Golf & Learning Center Budget for the fiscal year ending December 31, 2015, with budgeted operating expenditures of \$3,271,790 and capital improvement expenditures of \$348,700; and, be it further

RESOLVED, that any expenditure level in excess of the approved amount that is not funded by a direct revenue increase must have the prior approval of the President or his/her designee and those amounts shall be reported on a periodic basis to the Board of Trustees.

Mr. Rogers indicated that the success within the University golf department in 2014 suggests a continued positive community reaction with the new Sharf Clubhouse and the Events Facility. Registrations remain steady in 2014; golf rounds were at 33,703 which is down slightly 1,530 rounds from the prior season. The 2013-14 winter season was very harsh to golf courses in our region. However, our golf courses came through very well comparably and in fact attracted some business from area clubs that were unable to get on the golf courses. He indicated that the Rick Smith Golf Academy is working out well and fiscally, it's the same as when OU had its own lesson program.

After discussion, Trustee Flynn, seconded by Trustee Scott G. Kunselman, moved approval of the recommendation, and the motion was unanimously approved by those present.

**Agreement between Oakland University and the Oakland University Campus Maintenance and Trades (OUCMT) November 1, 2014 – October 31, 2017**

Mr. Ronald P. Watson, Assistant Vice President for University Human Resources, presented the Agreement between Oakland University and the Oakland University Campus Maintenance and Trades (OUCMT) November 1, 2014 – October 31, 2017 recommendation as set forth in the agenda item.

RESOLVED, that the Board of Trustees approves the Agreement Between Oakland University and the Oakland University Campus Maintenance and Trades (OUCMT), November 1, 2014 – October 31, 2017.

Trustee Robinson indicated that he did not like the lump-sum payment, as it doesn't increase the base compensation over time. He would vote against the contract but since the OUCMT approved it, he will vote for it.

After discussion, Trustee Tull, seconded by Trustee Kramer, moved approval of the recommendation, and the motion was approved with seven affirmative votes and one abstention by Trustee Flynn.

**Approval of Authorization for Residential and Retail Food Services on Campus**

Mr. Glenn McIntosh, Interim Vice President for Student Affairs and Enrollment Management, presented the Approval of Authorization for Residential and Retail Food Services on Campus recommendation as set forth in the agenda item.



RESOLVED, that the Interim Vice President for Student Affairs and Enrollment Management be authorized to negotiate and execute a food services agreement with Compass Group North America-Chartwells Higher Education for residential and retail food services on campus; and, be it further

RESOLVED, that the agreement will provide that food services may be shut down in the event of Oakland Center renovations; and, be it further

RESOLVED, that the agreement will provide that updated financial statements will be provided by Compass Group North America-Chartwells Higher Education upon request by Oakland University throughout the duration of the agreement.

RESOLVED, that the agreement be reviewed and approved by the Vice President for Legal Affairs and General Counsel prior to execution, and be in compliance with the law and with University policies and regulations, and conform to the legal standards and policies of the Vice President for Legal Affairs and General Counsel.

Mr. McIntosh explained the process of choosing Chartwells to be recommended to the Board for approval of the food services agreement. Chartwells offered the most financially beneficial proposal to the University. \$7.8M will be earmarked for capital investment improvements including such areas as the food court, upgrades to Vandenberg Dining Center, and a new dining facility in the lower level of the Oakland Center as well as needed renovations to our eight satellite locations across the campus.

In response to a question from Trustee Robinson, Mr. McIntosh indicated that compensation to employees was not one of the criteria in selecting the vendor but that the information on compensation was provided by each of the vendors. Trustee Robinson relayed that he feels that the compensation paid to employees should be a consideration when selecting vendors that have employees that work on campus.

In response to a question from Chair Schlussel, Mr. McIntosh indicated that the contract would allow for the food services to be shut down in the event of Oakland Center renovations. Chair Schlussel requested that this be made an amendment to the motion for approval.

In response to concerns from Trustees DeVore and Trustee Kramer, a motion was made to amend the proposal to require Chartwells to provide updated financials throughout the agreement.

After discussion, Trustee Tull, seconded by Trustee Stolicker, moved approval of the recommendation as amended, and the motion was approved with seven affirmative votes and one negative vote by Trustee Robinson.

#### **F. President Report**

President Hynd reviewed his initial aspirations that were presented in his last report. He is currently connecting with alumni and within the next couple of weeks, he will have more meetings with graduates to see how they profited from attending Oakland. He has had the opportunity now to meet with some of our local government officials including Bryan Barnett of Rochester Hills, Jaymes Vettraino the Rochester Hills City Manager, and currently has an opportunity to meet and discuss our relationship with Tom Tanghe of Auburn Hills City Manager. In a meeting with the Rochester City Manager and Mayor Jeffrey Cuthbertson, he found out that there are a number of internships that our students have with the City Manager and the Mayor also mentoring some of our students particularly with regard to our public administration and our human resources programs. He learned that the city fire department for Rochester conducts our CPR classes for the OU nursing program. Also, the Bear Bus collaboration is a very good example of us working with local communities so that our students can get out experience what each of our surrounding communities have to offer as part of their student life particularly, those that are living here on campus. We have reached out to and responded to overtures from Pontiac to become more engaged in efforts to move Pontiac forward.

Once the strategic plan is approved by the Board of Trustees in February or soon thereafter, he will launch several task forces to take a look at administrative issues to move Oakland forward strategically in ways that advance what we want to do in our strategic plan. All of the deans have been or are working on developing strategic plans that will be linked to the overarching strategic plan.

Oakland received the report from LCME on Medical School accreditation. It's extremely comprehensive and very positive from our standpoint. Oakland will submit any corrections of errors of fact and/or concerns overtime. At that point in time, once those are received, the final report from the LCME accreditation team will be submitted and we should hear in April of next year as to our final accreditation determination.

There's an opportunity for us to take a look at not only our branding about how we advertise ourselves to the larger community and to take a look at our own internal branding. As a result, he launched an internal branding task force. This task force will focus in on our internal identity, our pride and visibility at Oakland University. We have participants on this task force from across campus including Deans Corcoran and Harper among other campus leaders.

#### **G. Dean's Report**

Dean Mazzeo of the School of Business provided the Dean's Report. Dean Mazzeo explained the accreditation of the School of Business. The School of Business has four academic departments; Accounting & Finance, Decision & Information Sciences, Economics and Management & Marketing. It has about 70 faculty. Dean Mazzeo



pointed out some of the accomplishments of the School of Business faculty including Mark Simon, Professor of the Year, from the state of Michigan. He also spoke of the achievements of Buck Dillon, Sherman Folland and Miron Stano, Karen Markel, Janell Townshend and former Dean Mohan Tanniru.

Dean Mazzeo also pointed out the accomplishments of School of Business alumni, including Fancesca Daniel, Rick Williams, Erika Eraqui and Jane Harper.

Dean Mazzeo presented data showing that the credit hours for the School of Business has been trending up and is at a 20 year high. He went on to explain many of the collaborations the School of Business Administration has or is discussing with the other schools at Oakland and the College of Arts and Sciences.

He explained in detail the SBA's major initiatives including experiential active learning, student experience, professional engagement and community engagement.

He concluded by thanking various alumni, Board of Visitors and others for not only financial support but support of the initiatives of the School of Business Administration.
