1. Steering Committee Election (H. Witt)

Comment: Article IV, ix. of the Constitution of the Oakland University Senate as ratified and amended May 2, 1977, and approved J une 2, 1977, governing election of the Steering Committee reads as follows: ix. The University Senate shall have a Steering Committee composed of the Provost of the University (or his designee) who shall serve as Chair- person, and six other Senators elected at the first Senate meeting of the Fall Semester. The Committee's term of office shall be two years. No more than two seats shall be held by Senators from any one faculty.
2. Motion from the Steering Committee updating standing committee compositions (G. Feeman).

MOVED that the following composition changes be approved for administrative appointments to Senate committees:

4. Academic Standing and Honors Committee
5. Admissions Committee
6. Campus Development and Environment Committee
7. Financial Aid Committee
b. Change "Director of Career Advising and Placement" to "Assistant Provost for Placement and Advising" in the Academic and Career Advising Committee.
c. Change "Director of Research and Instructional Services" to "Director of Research Services" in the Academic Computing Committee.
d. Change "Vice President for Business Affairs" to "Vice President for Administrative Affairs" in the Academic Policy and Planning Committee.
e. Change "Assistant to the Controller" to "Controller" in the Financial Aid Committee.
f. Change "Director of Research and Instructional Services" to Vice President for Academic Affairs and Provost (or his/ her designee)" in the Teaching and Learning Committee.

Procedural Motion: debatable, amendable, and eligible for vote at this meeting.
Comments: Recent reorganizations have altered the titles and responsibilities of a number of individuals, requiring that the membership designations of several committees be altered. In all cases these changes merely reflect revisions in title and have no effect on the number of committee members or the balance of administrative, faculty, and student appointments.
