- A. IX. Discussion Topics

X. Legislative Updates

- A. Updates related to Legislative Projects and Initiatives
 - Legislator Hubbard has made some progress on the bike share project and she thinks she has found an organization to work with that's main goals are to help new projects, she could provide those interested with more information.
 - a) Ms. Kleinschmidt asked if the proper contracts have been discussed to meet Oakland's standards
 - b) Jean Ann asked if Legislator Hubbard contacted the Rec center about their bike share program
 - c) Legislator Hubbard said that they knew about it but has not gotten any information about the pas
 - d) President Mishack stated that she believes with this new program they wanted to do it a little bit differently
 - e) Jean Ann said it is similar to what we want but it was stopped due to thefts of the bikes
 - f) President Mishack said that with this new program they are looking for ways to prevent theft
 - g) Legislator Williamson said that they discontinued the previous program at the beginning of the past academic year due to theft
 - Legislator Fox, started by talking about the new system for legislator hours on google doc, legislators only have to do one hour a month during the summer and as long as they have an eboard member pull up the document and sign off on the hours. He then started talking about his plan for an umbrella exchange across campus. Essentially a rack with umbrellas in each of the buildings so that students can walk to from building to building without getting wet and then when they get to the new building they put in on the rack there. Thirdly the decision of a dress code for congress such as a business casual and the input of the congress is greatly appreciated to avoid any issues
 - a) President Mishack followed with this is something that is standard but it is not in the bylaws but it is something that would be better for the congress, especially when we have guests, to make us look presentable

- b) Legislator Gunn asked about doing a food drive, called water wars making it a cool competition but she wanted to know how to go forward.
- c) Legislator Merogi said that after meeting she would be more than willing to help her out with a bill.
- Legislator Anushree gave an update about the bench, it is in but if we would like a dedication it is a conversation that we would have to have if we are interested as a student congress.

B. Questions related to Legislative Reports

XI. Executive Reports

- A. Student Body President, Lena Mishack
 - President Mishack said that her and Vice President Shkoukani have been working with athletics about the combining of the cheer and dance teams. There will be the spirit squad which is a performance based group but there will still be competitive teams. They have been to several meetings discussing the details of what this all means, and the budgets for it. In addition, they have discussed bringing back the accessibility committee to start working on the issues around campus in addition to what the student services committee.
- B. Student Body Vice President, Jousef Shkoukani
 - He also mentioned the dance and cheer team situation and that it is still in process but it is looking promising. Again they have met with the dean of students about accessibility on campus and how to display the need for these matters to be looked at. He has also been working with career services about getting a larger variety of employers at the fall career fair to better help the students as they are job hunting.
 - a) Legislator Jagtap asked about the spring break change, if it is going to be implanted this year or what it is going to look like.
 - b) Vice President Shkoukani said that they currently are locked in by a contract and also have concerns about the professors on campus using it as leverage to try to change other parts of the congress. They head is on bored they just have to make sure that everyone can be on board. The contract update should be in the upcoming year so in the near future but not this academic year.
 - c) Legislator Merogi said that the idea of using wheelchairs to truly understand the issue about accessibility on Oakland's Campus.
 - d) Legislator Williamson said that he is also incredibly interested in this idea, but has questions about the master plan for the renovations in compliance with the better accessibility
 - e) President Mishack said that with the new construction they have laws requiring it already but they are planning on keeping in touch to make sure it happens
 - f) Legislator Fox mentions that he has heard about the addition of two new elevators, not so much about bathrooms
 - g) President Mishack said that they haven't heard that but know that in accordance with ADA laws they should have too

- h) Legislator Merogi said that she knows for a fact about the addition of a unisex handicap accessible bathroom
- i) Jean Ann suggested having the director of the OC come in as a guest speaker to answer any of the questions that we have about the renovations, especially regarding these issues and our office
