2. Program Modifications approved by Graduate Council
- a. Program Modification to the Master of Science in Exercise Science in the School of Health Sciences eliminating the GRE and supplemental application requirements, eliminating the statistics prerequisite and changing the requirements for CPR and First Aid, and reducing the number of credits required for the degree from 36 to 32 by changing the second internship course (EXS 6955) from a requirement to an elective.
 - b. Program Modification to the Master of Business Administration in the School of Business Administration changing the instructional delivery method to 100% online, limiting the online program to those who do not have a bachelor's degree in business and limiting students to electives with online sections.
 - c. Program Modification to the Master of Public Administration in the Department of Political Science in the College of Arts and Sciences changing the instructional delivery method to 100% online.
 - d. Program Modification to the Graduate Certificate in Oncology Rehabilitation in the School of Health Sciences changing the admission requirement to allow applicants with degrees in occupational therapy and speech language pathology or who are physical therapist assistants and certified occupational therapist assistants holding a bachelor's degree. All applicants must be licensed, registered or certified or hold equivalent credentials in their country of residence.
3. Request from the School of Nursing approved by the Graduate Council to reinstate the Clinical Nurse Leadership program and to modify the program to align the curriculum with the 2014 American Association of Colleges of Nursing Standards and reducing the number of credits in the program.
